1. Groundwater Withdrawal Transfers

2. Well Construction Program

- 15 "Drill Through the Edwards Aquifer" well permits.

Activities Summary:

During the reporting period, field inspection technicians maintained AMR sites, logged data, updated PLC's with the latest firmware, and performed maintenance at all 59 AMR sites. Meter staff completed annual site visits to 90% of irrigation well meters, and 85% of municipal and industrial well meters. Meter staff prepared and mailed out approximately 900 Annual Groundwater Withdrawal Use Reports to permit holders, which also included about 120 Limited Production Wells (LPWs) and 24 AMR reports. Meter staff completed all year-end downloads at the 59 AMR sites during the last week in December as part of the annual groundwater reporting submittal process. Meter staff completed development of the *EAA Meter Matters Smartphone App*, and introduced the App to permit holders in the annual use reporting mailout.
