Following is a report of permit-related activities and informational items for December 2025:

1. Groundwater Withdrawal Transfers

In December 2025, EAA staff completed processing 52 transfers which consisted of the following:

2. Well Construction Program

In December 2025, EAA staff issued 35 water well construction permits consisting of:

- 14 exempt Edwards Aquifer domestic well permits;
- 6 exempt Edwards Aquifer livestock well permits;
- 5 well capping permits;
- 7 well plugging permits; and
- 3 “Drill Through the Edwards Aquifer” well permits.

During the month of December 2025, field technicians reviewed and verified data in EAGIS for accuracy to begin generating 2025 Annual Groundwater Use reports for Permitted, LPW and Non-Permitted wells. Our annual mass mail out of 796 permitted well reports was scheduled for December 15th and 16th and 263 LPW Annual reports scheduled for December 31st. They continued to attempt to schedule all remaining wells for site inspections: Municipal, Industrial,

Irrigation, LPW and non-permitted wells. Two teams conducted the annual site inspections for 120 SAWS wells in coordination with SAWS staff. Not all wells were visited due to renovations and out-of-service site locations. All wells for City of San Marcos are now AMR, after the last installation was completed this month. Our Automated Meter System Technicians continue to monitor, collect and evaluate data received from 212 AMR sites through our Clear SCADA production server for preventative maintenance with the assistance of our field technicians as needed. They continue to update and switch out SIMs cards with 57 of the 212 stations having been completed. This should cut our communication costs of \$24,000 by half.
