During the month of March 2024, field inspection and electronic technicians continued installing, monitoring, collecting, and evaluating data received from 184 AMR sites through our Clear SCADA production server. The team has completed processing, correcting and validating 2023 annual groundwater withdrawal reports received during the February 2024 grace period. Permit holders who did not meet the reporting submittal deadline are considered as "non-reporters" and will be notified of this status until they submit their annual reports. Those who do not comply will be subject to enforcement. The team also continues its efforts to close unauthorized, and non-metered well violations by conducting site visits.
