Current Physical Description of Place of Use:

The current place of use consists of 69.720 acres, located in south San Antonio on Lackland AFB, just west of Kelly Field on Morey Road. On January 31, 2001, the EAA issued IRP P100-158 (BE00059) with 64.700 acre-feet of base irrigation groundwater (BIG) due to the irrigation of 64.700 historically irrigated acres (HIA) to Robert Suberg and wife, Lucille Suberg. On June 19, 2007, the EAA approved the transfer of ownership of P100-158 (BE00059) to Mildred Celina Verstuyft, Lorraine Agnes Wauters, and Norman Robert Suberg.

Description of Change in Land Use:

The 64.700 HIA with 64.700 acre-feet of appurtenant BIG are no longer practicable to farm due to the following limitations: the land is located in the City of San Antonio city limits; the land is bordered and encompassed by Lackland Air Force Base and its surrounding facilities. The 64.700 HIA have not been irrigated for more than five years.

Staff Calculations:

In accordance with EAA Rule § 711.342 (6) (B) Basis for Granting Conversion Applications, the historically irrigated land that is the subject of the application is no longer practicable to farm as evidenced by the afore mentioned limitations to the 64.700 HIA.

Staff Recommendation:

EAA Staff recommends approval of the Application to Convert Base Irrigation Groundwater requesting to convert 64.700 acre-feet based on a change in land use. The application will be reviewed at the March 28, 2017 Permits/Enforcement Committee meeting and the April 11, 2017 Board Meeting.
