1. Groundwater Withdrawal Transfers

In March 2017, EAA staff completed processing of 38 transfers which consisted of the following:

2. Well Construction Program

During the past month, field inspection technicians continued maintenance of AMR sites, logged data, updated PLC's with the latest firmware, and performed maintenance at all 59 AMR locations. Technicians conducted several meter reading site visits in conjunction with the remaining annual use non-reporters to ensure that annual groundwater withdrawal reports are received. Additionally, staff performed meter accuracy verification testing at 21 well/meter sites during this month.
