Current Physical Description of Place of Use:

The original IRP was granted due to historical irrigation of 66.600 acres, located one mile north of San Marcos, on the east side of Lime Kiln Rd in Hays county. On October 8, 2002, Permit No. IRP 2002-HA00227 (P100-833) was issued to Don B. Meador and Karen S. Meador. On June 13, 2017, the place of use for P100-833 was amended to include an Irrevocable Designation of Historically Irrigated Lands Pertaining to Edwards Aquifer Groundwater Rights. Currently, the 66.600 acre-feet BIG are located on the 66.600 designated historically irrigated acres (HIA). The 66.600 HIA are being utilized for agricultural use and are the subject of this Conversion of Base.

Description of Conservation Equipment:

Three (3) Greenfield center pivot irrigation systems were installed on the HIA: a 9 span pivot in September 2004, a 5 span pivot in December 2005, and a 7 span pivot in May 2007. The pivots utilize a Mid-Elevation Spray Application (MESA) to irrigate approximately 50.000 base acres.

Staff Calculations:

Staff calculated the area under the pivots and found that 50.000 base acres are currently being irrigated under the pivot system. EAA staff has calculated a projected savings of 20.588 acre-feet by the installation of the pivot system. In addition, staff calculated corner credit of 16.600 acre-feet based on the standard calculation for the center pivots (50.000 acres under the pivots subtracted from the total 66.600 base acres). Corner credit is calculated on the standard based one acre-foot per acre (considering a 75 percent coverage of the base acres and a base ratio of 1.000 acre-foot/acre). The total conversion as calculated by EAA staff is 37.188 acre-feet.

Staff Recommendation:

Staff recommends a conversion be granted for 37.188 acre-feet. The application will be reviewed at the June 27, 2017 Permits/Enforcement Committee meeting and the July 11, 2017 Board Meeting.
