# **Current Physical Description of Place of Use:**

The original IRP was granted due to the historical irrigation of 396.200 acres (HIA) located on Old Pearsall Rd between IH Loop 410 and SH Loop 1604, in southwest Bexar County. 208.000 HIA have been the subject of two previous base conversions due to a change in land use. Currently, the remaining 188.200 HIA have been leased to Verstraeten Bros. Farms, Inc. through 2026, and are being irrigated with Edwards well W100-109. Two 0.500 acre-tracts of HIA containing the two points of withdrawal associated with this POU have been surveyed out of the HIA and are not the subject of this application.

## **Description of Change in Land Use:**

The historically irrigated land has been acquired by an entity with the power of condemnation or eminent domain, and the entity uses the land in a manner within the entity's legally authorized purposes.

### **Staff Calculations:**

In accordance with EAA Rule § 711.342 (6) (C) Basis for Granting Conversion Applications, the historically irrigated land that is the subject of the application has been acquired by an entity with the power of condemnation or eminent domain, and the entity uses the land in a manner within the entity's legally authorized purposes.

### **Staff Recommendation:**

Staff recommends a conversion be granted for 187.200 acre-feet. The application will be reviewed at the January 23, 2018 Permits/Enforcement Committee meeting and the February 13, 2018 Board Meeting.
