1. Groundwater Withdrawal Transfers

2. Well Construction Program

In October, November, and December 2017, EAA staff completed processing of water well construction applications which consisted of the following:

- 7 exempt Edwards Aquifer domestic well permits;
- 9 exempt Edwards Aquifer livestock well permits;
- 1 exempt Edwards Aquifer domestic/livestock well permit;
- 1 non- exempt Edwards Aquifer municipal well permit;
- 1 Edwards Aquifer alter or reconstruct existing nonexempt municipal well permit;
- 6 well capping permits;
- 20 well plugging permits; and
- 24 "Drill Through the Edwards Aquifer" well permits.

Other Dates:

During the final three months of the year, electronics technicians continued monitoring AMR sites, updated PLC's with the latest firmware, retrofitted enclosures, and performed maintenance at all 59 AMR sites. During October and November, field inspection technicians performed annual visits to permitted wells in all counties; and in November, inspected all SAWS wells. In December, technicians installed 5 new electromagnetic flow connect meters as part of the Texas Water Development Board (TWDB) grant. EAA meter staff also prepared and mailed approximately 1,200 annual use reporting forms to permit holders and LPW owners in mid-December.
