1. Groundwater Withdrawal Transfers

2. Well Construction Program

- 1 non- exempt Edwards Aquifer irrigation well permit;
- 1 monitoring well construction permit;
- 2 well capping permits; and
- 8 “Drill Through the Edwards Aquifer” new well permits.

During the month of March 2018, field inspection technicians continued their efforts to reach out to non-reporters to solicit Annual Groundwater Use report for all permitted wells and LPWs. Additionally, electronic and field technicians continue monitoring 59 AMR sites, and working with our Information Technology (IT) staff in trying to get Radio Communications established at our AMR stations sometime during the month of April. Currently, stations continue to log meter data utilizing manual downloading process at each AMR site.
