During the month, field inspection and electronic technicians continue monitoring 59 AMR sites, and working with our Information Technology (IT) staff to retrofit our AMR stations with cellular telemetry. Currently, stations continue to log meter data utilizing manual downloading process at each AMR site. Additionally, technicians continue to conduct annual meter readings at well/meter sites in Uvalde, Medina, Comal/Hays, Guadalupe & Bexar Counties. Field Inspection technicians continue to canvass Uvalde, Medina, and Bexar counties for meter calibrations, testing will continue throughout the year until completed.
