- 3 well plugging permits; and
- 6 "Drill Through the Edwards Aquifer" well permits.

During the month, field inspection and electronic technicians continued monitoring, collecting, and evaluating data received from 77 AMR sites, and the team installed three more functional AMR sites in Uvalde & Medina County. Also, field inspections technician assisted members of the compliance team in identifying annual groundwater withdrawal non-reporters, creating violations, and conducted site visits to estimate usage for 2018.
