Current Physical Description of Place of Use:

Property consists of 60.120 historically irrigated acres located south on Hwy 83 in Uvalde County, Texas. Property also known as "Rocky Acres" and was formerly owned by Mr. A.M. Rimkus.

Description of Water Conservation Equipment:

The water conservation equipment is described as One Valley Model 8000 galvanized center pivot with Mid-Elevation Spray Applicators (MESA). Installation date regarding water conservation equipment was October 22, 2009.

Staff Calculations:

EAA staff calculated the area under the pivot system to be 34.102 base acres. Staff has calculated a projected water savings of 15.278 acre-feet due to the installation of the water conservation equipment. In addition, staff calculated corner credit of 5.093 acre-feet based on the standard calculation for center pivots. EAA staff has determined that the total amount of base irrigation groundwater that is eligible for conversion due to the submission of this application would be 20.371-acre feet.

Staff Recommendation:

EAA staff recommends a conversion be granted in the amount of 20.371 acre-feet. The application will be reviewed at the March 10, 2020 EAA Board meeting.
