2. Well Construction Program

- 1 non-exempt Edwards Aquifer municipal well permit;
- 1 non-exempt Edwards Aquifer irrigation well permit;
- 1 closed loop geothermal injection wells permit;
- 6 well plugging permits; and
- 5 "Drill Through the Edwards Aquifer" well permits.

During the month of August 2020, field inspection and electronic technicians continued monitoring, collecting and evaluating data received from 92 AMR sites through our ClearSCADA production server. The meter team continues to monitor meter readings via the Meter Matters App, data received from LPW owners and continues to review and test EAGIS 2.0 and the EAA's online reporting portal. Additionally, the team has started their annual meter reading site visits at all permitted Municipal/Industrial well sites in Uvalde, Medina, Bexar, Hays and Comal Counties.
