Meeting Minutes

Director Deborah Carington acknowledged General Manager Roland Ruiz's trip to Memphis, Tennessee to present the story of the Edwards Aquifer, which was at the invitation of an organization known as Protect Our Aquifer. Other event co-sponsors included the Wolff River Conservancy, the University of Memphis, the Sierra Club, Clean Memphis, and the Southern Environmental Law Center.

Director Carol Patterson announced that she would be serving on a technical advisory committee in support of a new strategic development planning effort for the San Antonio International Airport. She would make periodic reports to the board in order to keep them informed.

Mr. Brock Curry, Deputy General Manager, made the following announcements:

- Mr. Paul Bertetti has been promoted from Research Manager to Director of Aquifer Science.
- As of this past Sunday, the San Antonio Pool was in Stage 2 critical period management. Paul would provide the board with more information regarding weather trends.
- As was mentioned in his email last week, Roland and Marc Friberg met with the Lt. Governor's staff on May 30 to brief them on pending litigation. Last Monday, they met with Senator Charles Perry (chairman of the Senate Committee on Agriculture, Water, & Rural Affairs) for the same purpose, before hopping a plane to Amarillo. On Tuesday, Roland briefed the House Committee on Natural Resources, chaired by Rep. Lyle Larson at its meeting in Palo Duro Canyon.

- Mr. Bertetti briefed the board on current aquifer conditions and weather trends.
